Rediscover Paris ANNUAL REPORT 2015



LEADERSHIP

In 2015, we asked our patients, staff, and community to "Rediscover Paris." This initiative was intended to focus their attention on our organization for healthcare needs.

We asked patients who had not been here in a while to rediscover the array of services that we now offer. We asked our established patients to rediscover our numerous improvements, upgrades, and additions. We also asked our staff to rediscover the progress that we made over the past year and to renew their commitment to our patients and organization.

To quantify our growth, we looked at a few key numbers, comparing 2015 to just five years prior. From 2010 to 2015, our number of employed providers increased from 15 to 24. Visiting specialty providers increased from 10 to 22. During the same period, our number of employees grew from 273 to 359.


Featured in our 2015 Rediscover campaign were Women's Health, Surgery, Radiology, New Providers, and the Emergency Department (see pages 2-3).

PROVIDERS

Five providers joined PCH/FMC in 2015, each of them representing different areas of the healthcare spectrum.

Manish Gorasiya, MD, board certified family practice physician, joined PCH/FMC after completing residency in Montgomery, Ala. His interest in geriatric medicine led to a successful transition of patients to him from Dr. Reid Sutton, who retired from his clinic practice. He also provides care for nursing home patients.

Jihui Li, MD, general surgeon, came to PCH/FMC after completing residency training at Cleveland Clinic in Weston, Fla. Originally from China, Dr. Li brought 12 years of surgery experience to the Edgar County community.



Annie (Wooten) Barrett, PT, DPT, doctor of physical therapy, returned to her home town of Paris after graduating from the University of Evansville. Prior to PCH/FMC, she worked as a physical therapist in Terre Haute.



Abby Barrett, LSW, licensed social worker, of Paris, joined PCH/FMC after working several years in the social services field in Edgar County. She obtained her degree in social work at Olivet Nazarene University in Bourbonnais and is pursuing her master's degree.



Maribeth McCormack, CRNA, certified registered nurse anesthetist, joined PCH/FMC after earning her master's degree in anesthesia from Southern Illinois University–Edwardsville. As a graduate student, she completed her anesthesia training at PCH/FMC, which serves as a clinical site for SIU-E nurse anesthetist students.

Rediscover Paris

PCH/FMC's "Rediscover Paris" campaign kicked off April 28 with a community open house. Hundreds attended the free event, which included interactive areas/items of interest to "discover" throughout the hospital and clinic. It also was an opportunity to meet new healthcare providers at PCH/FMC.

The Rediscover Paris campaign continued throughout the year and was featured at two Paris Area Chamber of Commerce & Tourism events, including a Business After-Hours Event September 24 at the hospital.

The campaign encouraged established patients, new patients, staff, and the community to focus their attention on the hospital, which had made significant improvements, upgrades, and additions over the past several years.

The campaign highlighted the growth and accomplishments in Women's Health, Surgery, Radiology, the Emergency Department, and the addition of New Providers.



Always Taking Time to Care for You

- Women's health services continued to evolve, providing gynecological care for all ages, complete urology care, single incision and advance gynecological surgery, and treatment of pelvic pain.
- Surgery was recognized for offering surgical services in nearly every specialty, advanced technology, and experienced staff. In 2015, the surgery department performed 1,663 surgical procedures, an increase from 1,372 in 2014 (see page 11).
- The radiology department was featured for its equipment upgrades, including a new 64-slice CT machine, making all services digital and "low dose," and providing 24/7 coverage.
- New providers included Jihui Li, MD, general surgeon; Manish Gorasiya, MD, family practice; Annie (Wooten) Barrett, PT, DPT, doctor of physical therapy; Abby Barrett, LSW, licensed social worker; and Maribeth McCormack, CRNA, certified registered nurse anesthetist (see page 1).
- The emergency department was credited with patient satisfaction scores above 90 percent, a short average wait time, experienced nursing staff with an average tenure of 23 years, and for becoming an Emergent Stroke Ready Hospital.



CLINICAL PROGRESS

In keeping with its mission to provide excellent patient care and promote wellness throughout its communities, PCH/FMC made great strides in its patient care initiatives. This included expanding services, adding new services, and implementing changes in response to the changing needs of healthcare.

Weight Loss Clinic

A new Medical Weight Loss Clinic opened in the Family Medical Center in early 2015 led by Crystal White, FNP-C, program manager, and her staff. The public was invited to free monthly informational sessions throughout the year to hear about this medically supervised, scientifically-based approach to weight loss. In its first year of operation, participants lost 1,150 inches and 1,235 pounds through the program, which utilizes the Ideal Protein approach.





Wound & Limb Salvage Center

Dr. Philip Holloway, podiatrist and wound care specialist, and Dr. Syed Hussain, vascular surgeon at Christie Clinic, teamed up to offer comprehensive care for patients suffering from peripheral vascular diseases (PVD). Initiatives of the program are coordinated through the PCH Wound & Limb Salvage Center. Patients have their office visits, testing, and lab work done at PCH, and travel to Dr. Hussain's Champaign location only if a procedure is needed.

Stroke Ready Hospital

The Illinois Department of Public Health (IDPH) recognized Paris Community Hospital as an Emergent Stroke Ready Hospital in January. The designation signifies IDPH is "confident that Paris Community Hospital will provide quality stroke care and assist in the delivery of care within the State of Illinois."

Respiratory Therapy The respiratory therapy department added more staff, enhanced its technology, and began providing 24/7 coverage with the addition of manager Amy Krabel. The sleep lab expanded to offer more nights of service and include daytime sleep studies for people who work night shifts.

ICD-10 Coding

PCH/FMC complied with federal law by implementing ICD-10 code sets prior to October 1, 2015. Staff received extensive training on this newest version for reporting medical diagnoses and inpatient procedures, which consists of 69,000 diagnosis codes compared to 14,000 codes contained in ICD-9.


New EHR

Important steps were taken toward the conversion of all electronic health records (EHRs) to athenahealth, with the initial implementation to occur in the Family Medical Center. The massive project included extensive data collection, user training, as well as setting up providers and payor information.

Accountable Care Organization

PCH/FMC became one of 21 critical access hospitals to join the Illinois Rural Community Care Organization–an accountable care organization (ACO) dedicated to providing higher-quality coordinated care to Medicare patients, while helping to slow healthcare cost growth. Dr. Sutton Retires

After 38 years of serving the community, Dr. Reid Sutton, internal medical, retired from his clinic practice August 31. On September 21, he began a

new role as a hospitalist physician. Dr. Sutton spent his entire medical career in Paris. He opened a private practice in July 1977, and became a PCH/FMC employed physician in September 2004.



VSC Build Out

Prompted by the need for additional clinical space, configuration of the Visiting Specialty Clinic was changed with the construction of 10 new offices for existing staff. New vinyl flooring, similar to that

in med/surg, was installed in the VSC, as well as in radiology and the emergency department.





Kansas Clinic Closure

After 19 years of serving southwest Edgar County and surrounding communities, the Kansas Family Medical Center closed March 31. The clinic staff, Susan Arp, FNP-C, and Carrie VonLanken, LPN, were transitioned to the Paris FMC. PCH/ FMC purchased the entire building that included the clinic, and donated it back to the village of Kansas.



New CFO

After 15 years of service as chief financial officer, Terry Brinkley announced his retirement from PCH/FMC, effective March 31. Martin Adams, finance manager, was named the new CFO and Kim Calvert replaced Adams as finance manager.



Med/Surg Renovations

Two patient rooms were renovated to comply with ADA restroom requirements, bringing the total number of ADA compliant rooms to five. A walk-in tub was installed in the salon and vinyl flooring replaced carpeting in the med/surg corridor.



Rural Health Alliance

PCH/FMC joined the Rural Alliance for Exceptional Care with Carle Foundation Hospital to help better coordinate care in the region and ensure that resources are available for patients closer to where they live. PCH/FMC continues to remain independent and operated by its local board of directors.



Land Purchase

PCH/FMC purchased the lot adjacent to the hospital at Court Street and Route 150, with no immediate plans for the property. The land was cleared of an old home and trees.

Athletic Trainers


PCH/FMC, which has provided an athletic trainer at Paris Cooperative High School for the past several years, added a second athletic trainer for Tri-County sports. The total program cost \$20,000, plus supplies. Funding for the athletic trainers is done through a partnership agreement with

Eastern Illinois University, which provides the trainers who are graduate students.


QUALITY

HCAHPS (hospital consumer assessment of healthcare providers and systems) is a federallyinitiated survey process that asks patients about a recent hospital stay. The 10-question survey highlights certain parts of the patient experience during that stay. Results can be evaluated comparatively to other area hospitals, state averages, or national averages. 




Willingness to Recommend Hospital



PCH Inpatient HCAHPS Report*



At PCH/FMC, the Quality/Infection Prevention Department shares reports on HCAHPS, as well as may other key measures. They report data to a number of organizations, including the Centers for Disease Control (CDC), and the Illinois Department of Public Health (IDPH).

The hospital participates in many collaborative quality initiatives, with state and federal agencies.

COMMUNITY INVOLVEMENT

PCH/FMC continued to offer free healthrelated events and programs for Edgar County students and the community as a whole.

Community Events

PCH/FMC engaged in community events and partnered with local organizations throughout the year. It participated in numerous fairs and festivals during the summer months, and partnered with schools to provide hands-on tours. Additionally, PCH/FMC provided the community with free vascular screenings, free bone density screenings, discounted health screenings, and education about various health topics.

Additionally, PCH/FMC continued to participate in the Dine With a Doc program, providing meal sponsorships and speakers on a monthly basis. PCH/FMC also sponsored several events of its own, including its annual caregiver event, diabetes foot clinic, Safe Sitter classes, grief programs, and various support groups.

In July, PCH/FMC sponsored its first ever "Back to School Bang" – a free back-to-school health and wellness expo for local students. Approximately 50 children attended the event, which featured more than 10 local organizations providing interactive displays and health education. Forty school/sports physicals and immunizations were performed, which were optional. The expo was initiated by the Family Medical Center's I-Care committee.

School Programs

PCH/FMC provided a series of wellness programs in Paris schools, including CPR/AED/ choking courses and diabetes screenings at Paris High School.



The Healthy Schools program was continued for fourth grade students in five Edgar County schools. The program, now in its fourth year, allows PCH/FMC dietician Jan Coombe to visit the schools and provide nutrition lessons. The program started in 2011 with grant funds, and has continued with subsequent funding provided by PCH/FMC. PCH/FMC sponsored its Coaches' Cookout at the new Paris High School, which attracted 35 area coaches, assistant coaches, and others. The annual event featured information about concussions and injury prevention, a barbecue meal, and free first aid kits for schools.

St. Mary-of-the-Woods College recognized PCH/FMC as a partner in its new nursing program, and for donations of equipment to its nursing lab, which included: hospital beds, bedside tables, linens, a gurney, and an incubator.


